

WAVE VOLLEYBAL CLUB ATHLETE FEE AGREEMENT

This Athlete Fee Agreement (the "Agreement") governs the financial commitments and obligations arising from accepting an invitation to join the Wave Volleyball Club for the 2025-2026 Season. The undersigned (the "Responsible Party") represents and warrants that they are the parent or legal guardian of _____ (the "Wave Athlete")

The "Fee" for each individual athlete for the 2025-2026 Season is One Thousand Seven Hundred Fifty and NO/100 DOLLARS (\$1,750.00). The Fee covers the cost of team equipment, gym rental for practice, limited general liability insurance, scheduled tournament entry fees, coaching stipend, and the standard uniform package attributable to the Wave Athlete. The Fee does not include any additional costs, including coaches' meals, travel, and lodging for away tournaments, additional entry fees for tournaments not on the standard schedule, and any team wear not included in the standard uniform package (the "Additional Fees"). The Additional Fees shall be paid by the parents of the respective team.

The Responsible Party promises to pay Wave Volleyball Club the entirety of the Fee for the 2025-2026 Season as provided for herein. The Responsible Party acknowledges and agrees that Wave Volleyball Club is relying on the promises and commitments contained herein as a condition to the Athlete signing with Wave Volleyball Club. The Responsible Party further acknowledges and agrees that if the Wave Athlete is unable to participate for any reason, including but not limited to leaving the team, injury, illness, or other unforeseen circumstances the team Fee shall not be refunded or prorated. If electing the full payment option, payment is due the day of contract signing. If electing the payment plan option, the Responsible Party agrees and promises to pay Wave Volleyball Club the initial deposit payment indicated below on the day of signing and the remainder of the balance due by the dates listed below. A late payment fee of \$25 will be assessed for payments not made by a due date, with a 2 day grace period.

Any changes to the payment schedule must be agreed to IN WRITING by both the Responsible Party and the Director of Wave Volleyball Club, signed and dated by both parties. Payments may be made by cash or check, or by credit card via the SportsEngine Website (additional fees may apply).

I acknowledge and understand that failure to make payments in accordance with the payment schedule may result in the Wave Athlete being ineligible to practice or compete with the team. I further acknowledge and understand that defaulting on this contract, including the payment plan obligations, may result in legal action against the undersigned responsible party to recover the delinquent amount. Upon default the entire amount due under the payment plan shall be accelerated and become due and owing. Any modification of this Agreement must be agreed to in writing by both the Director of Wave Volleyball Club and the undersigned responsible party on an addendum to this Agreement.
